MSA CIRCUIT RACING CIRCULAR 3/2005

124987/144

For all Vodacom Power Tour events, the following shall apply until further notice:

1. Each event organiser shall ensure that at a suitably graded Clerk of the Course and/or Assistant Clerk of the Course is appointed to act alongside the permanent category Clerks of the Course.
2. MSA and Club Stewards shall be appointed for the event as per normal but, notwithstanding the provisions of the regulations, they shall not be responsible for the hearing of protests. They shall however remain responsible for all other duties and responsibilities of the Stewards outlined in terms of the regulations.
3. The appointed Clerks of the Course, together with the Assistant Clerk of the Course (where applicable), shall form a 'protest panel' responsible for the hearing of protests. At least two members of this panel, preferably three, shall form a quorum to hear a protest. It stands to reason that any member of the panel who makes a decision that becomes the subject of a protest may not sit as a member of the 'protest panel' for the particular hearing.
4. Any competitor aggrieved by the decision of the 'protest panel' shall have the right of immediate appeal to an 'appeal panel' to be constituted on an ad hoc basis comprising three members from amongst the following:

None of the above may sit on any appeal where they have been involved in the decision under appeal, or where they may be perceived to have some other conflict of interest.

5. Any appeal to be considered by the above-mentioned 'appeal panel' shall be lodged in accordance with the regulations (including fees payable) governing the lodging of an appeal to a MSA Court of Appeal.
6. The 'appeal panel' shall act as a MSA Court of Appeal and shall make a ruling as to whether an appellant is to be granted the right of further appeal as part of its findings on the appeal before it.
7. Any application for leave to appeal and/or formal appeal arising from a decision by the 'appeal panel' shall be considered by the MSA National Court of Appeal.
